| <input type="checkbox"/> | Virginia Preschool Initiative (VPI) | Classroom funded by state grants and local matching funds under VPI for at-risk four-year-olds. | 21 |

| <input type="checkbox"/> | Coordinated Special Education | Student spends part of the day in a preschool special education program and part of the day in a pre-kindergarten program for non-disabled peers, such as VPI, Title I, Head Start, or child day care. | 30 |
| <input type="checkbox"/> | Special Education Only | Student participates in one program that serves only students with disabilities or developmental delays. | 31 |
| <input type="checkbox"/> | Government – Tuition Charged | Pre-kindergarten or child daycare program operated by a government agency in which parent/guardian is charged tuition. | 40 |
| <input type="checkbox"/> | Private Provider | Preschool, child daycare, or other program, including programs from for-profit and non-profit providers, faith-based programs and commercial daycare centers. | 50 |
| <input type="checkbox"/> | Licensed Family Home Daycare Provider | Preschool or child daycare provided in a home where the provider is licensed by the state. | 51 |
| <input type="checkbox"/> | No Formal or Institutional Pre-K Program | Student is at home with a caregiver or in the home of another caregiver not licensed by the state. | 60 |
| <input type="checkbox"/> | Other | Student attends a preschool or child daycare program that does not fall into any of the above categories. If your child attended a combination of any of the above programs, do not use this category and instead select one of the above programs as the primary provider. | 61 |
